'The new members join our inaugural Chair, Gerard Dalbosco, in leading this exciting new era for Catholic education in the Archdiocese of Melbourne,' Archbishop Comensoli said.

'The establishment of MACS has been a necessary and constructive change to Catholic education in the Archdiocese, and the appointment of these new board members serves to not only reflect community expectations about the operations of schools, but keeps our Christ-centred mission at the heart of all we do in Catholic education.

'MACS is blessed to have these experienced and respected industry, educational and Catholic-community leaders joining the board.'

Chair of the Board, Gerard Dalbosco, said that the parents and families of the more than 110,000 students attending Catholic schools governed by MACS can feel confident about the board chosen to lead the sector in this new era.

'MACS will be responsible for the governance and operation of 290 Catholic schools in the Archdiocese of Melbourne from 1 January 2021,' Mr Dalbosco said.

'It will make us the sixth-largest school governing authority in the country after the state school systems in NSW, Victoria, Queensland, Western Australia and South Australia.

'This is an immense task, but our new board members will bring their significant skills and commitment to the task of leading this new era for our schools.'

MACS will officially begin its governance responsibilities on 1 January 2021.
